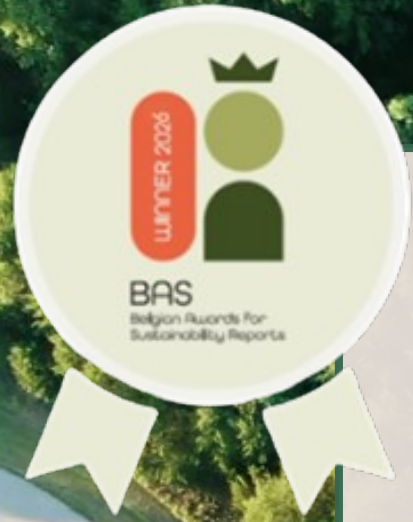

The BAS rewards reports that:

- ◆ Show impact
 - ◆ Make performance measurable
 - ◆ Make targets specific
 - ◆ Are transparent about challenges
 - ◆ Are useful for decision -making for stakeholders
- ◆ Tip: do not only show “what you do”, but also “what the benefit is”.

Why would you report about sustainability?

Strategy : because it will accelerate you quicker — internally and externally

Reporting (mandatory or voluntary) makes performance measurable, choices transparent and ambitions credible. Successful companies make the difference here!

- ◆ Fewer ad hoc “ESG-questions”

For who is the BAS 2026?

For you — if your organisation publishes sustainability information in 2026 about 2025, regardless of your size or legal form:

Companies in scope of the CSRD

◆ With CSRD/ESRS ESG-reporting

Large companies which report on a voluntary basis

◆ Growing reporting: structure, KPI's, targets

SME's & associations which report voluntarily

◆ Clear, relevant, honest, appropriate metrics



Core: relevance and credibility

What makes it unique is that the reporting is the foundation for the Awards. The BAS does not focus on nice words, but on what matters for your organisation—and how you substantiate that with strategy, good governance, relevant and credible data, and results.

What is being evaluated?

The criteria start from the following question: is your reporting useful and credible for internal and external stakeholders?

Material topics

What is truly relevant for your impacts, risks and opportunities?

2

KPI's & performance

Measurable, consistent, with explanations for trends.

3

Objectives & roadmap

Integrating ESG into strategy, ambition, milestones and governance.

4

Value chain & risk

Insight in the value chain, due diligence and mitigation.

5

Transparency

Balanced: success and challenges, clearly supported.

Prepare your 2025 publication and plan your participation



Useful tips:

- ◆ Use your existing report (ESG report, or annual report with a sustainability section)
- ◆ Add a 1-page “highlights” summary for the jury (KPIs, targets, key achievements)
- ◆ Make sure challenges are also mentioned – this increases credibility

2026 = 25th edition : An edition with additional visibility
